- 3. In all circumstances, the life of both the mother and baby should be valued, which is why I support the \$160 million in appropriations to support mothers and their babies. Seventy-six percent of women polled said if they thought they had a choice other than abortion, they would have chosen life. I have worked first-hand with some of these women through Project Gabriel, a group that provides economic and emotional support for pregnant women. This is the best way to help pregnant women in North Carolina.
- 5. In addition to the burden pot legalization has placed on public safety, we now have studies that show the adverse health effects of weed which include a significant risk of lung cancer, psychosis, and depression. I am not convinced that medical marijuana's purported health benefits justify the ill effects. Cancer is a horrible disease—I personally know people who have battled it, but it is not in the best interests of North Carolina to legalize medical marijuana.
- 6. No one should be discriminated against. In all policy we must ensure protections crafted for one group do not violate the rights and safety of others as such laws may infringe on free speech and religious freedom rights; however, the SCOTUS *Bostock* decision found that sexual orientation and gender identity are protected classifications.
- 12. Parental rights are important for the safety of children. When risky behaviors are concealed from parents, children are put in danger and the role of parent switches to the doctor. For example, a Charlotte mother was informed that her 12-year-old daughter ingested a gummy possibly laced with drugs while at school. The mother was told by the hospital that her daughter refused testing. North Carolina law supports the rights of the pre-teen over the mother. The emotional disturbance element is broadly defined and could allow life-altering gender drugs and procedures without parental consent. Many healthcare decisions have consequences for a lifetime and parents should be informed and have rights to consent.
